

Rules and Regulations for visitors of Soaring Media Complex

Soaring performance is available for people above 120 cm and not more than 195 cm, weight limitation is 136 kg. The Media Complex is designed to operate not more than 39 people simultaneously. Children under 12 years old are allowed on sessions only when accompanied by an adult in charge sitting in the adjacent chair.

Attendance in Soaring performance is prohibited for:

- People in a state of alcohol or drug intoxication, as well as under the influence of other chemical substances which can affect senses, reflexes and motion coordination

- Pregnant women

- People with the following health problems:

- heart disease or high blood pressure
- back or neck pains
- sea sickness, dizziness or epilepsy
- sensitivity to flashing lights
- claustrophobia

Rules of conduct during the performance:

- Comply with requirements of the park staff during the operation of Media Complex (including staying in the pre-show area, seating and getting off the attraction)
- Do not use personal things which can fall out during the motion and damage the screen (hats, scarfs, loose shoes, umbrellas, toys, walking sticks, bags, cell phones, cameras etc.)
- Adults must sit next to the accompanied child
- Pets are not allowed at session
- Eating, drinking, smoking, and gum chewing are forbidden at session
- There is a free seating system in the pre-show zone. Park staff do not guarantee the desired way of pair or group seating. On the platform visitors should occupy similar places as in the pre-show zone
- Do not enter the landing platform and do not take seats without operator's permission
- Stay in your seat until the end of the performance
- Secure your position by fastening seat belts
- During the performance visitors must additionally fix their position by putting hands on the armrests
- Do not stand up during the performance
- Do not place your hands on or into the moving parts of the construction of the Media Complex
- In case of emergency, stay calm, do not try to leave the seat yourself and follow operator's instruction (specific safe evacuation measures will be activated)

Strictly forbidden:

- Unbalanced loading of the platform
- Participation of people whose physical condition does not allow them to be fixed with safety belts, people below 120 cm and above 195 cm, and those whose weight exceeds 136 kg, as well as people in a state of alcohol, drug or other intoxication
- Seating children on the lap
- To have unset elements of clothing or shoes, cell phones, cameras and other objects that can be thrown or sandwiched in the moving parts of the attraction, as well as objects that can damage the screen if dropped – hats, scarves, umbrellas, toys, walking sticks etc.
- Putting hands close to the moving parts of the attraction and inside of the Media Complex
- Unfastening seat belts

Visitors are responsible for damage and (or) destruction of of Zaryadye Park property in accordance with the current legislation of the Russian Federation.
